REGULATIONS

1. Announcement:

The Spey Valley Classic, Sports and EV Car Tour will be held on Sunday 11th May 2025 and is organised by The Rotary Club of Spey Valley. The event will start and finish in Aviemore.

2. Car Eligibility: All Vintage, Historic, Classic Cars, Modern Sports Cars and EV and Hybrid Cars are welcome. Entries are limited to a maximum of 60 cars.

3. Entries:

The Entry List opens on publication of these Regulations and Entry Form.

The Entry List closes on May 4th 2025, or when a maximum of 60 entries is received.

There will be **NO ENTRY FEE** for what is promised to be a day of fun and fellowship amongst like-minded car enthusiasts, however all entrants are asked to raise **SPONSORSHIP - MINIMUM of £75 per car** with all funds raised going to the three nominated charities.

Please seek donations and sponsorship from friends, family and business associates to assist in raising funds by completing the separate sponsorship form. Please remember to tick the Gift Aid box if applicable - this will increase any donations by 25% if the sponsor is a UK taxpayer; sponsors MUST include their house name or number and post code to enable us to reclaim Gift Aid.

All donations will go to the Rotary Club of Spey Valley Charitable Trust for distribution to the nominated charities and local causes.

The sponsorship form together with the monies collected can be handed in on the day or sent not later than 7 days after the event to Alan Cairns, 4 Dalmore Road, Carrbridge PH23 3BG. Please make cheques payable to the Rotary Club of Spey Valley Charitable Trust.

4. Included are:

- Rally Plates for each car
- Road Book and Map
- Souvenir Awards for all entrants

5. Special Awards:

- Entrant collecting most sponsorship.
- Oldest car to complete the tour.
- Car driven furthest to participate.











6. Route Navigation and Driving Behaviour:

The route will be on public A and B class and some unclassified roads. The route will be defined by Tulip diagrams. A Road Book and Map will be provided.

Please remember other road users, cyclists, walkers and livestock. Please do not hold up the traffic.

Participants must at all times comply with the requirements of the Road Traffic Acts and drive in a responsible and considerate manner, making due allowance for weather and road conditions.

In the event of a traffic accident/incident drivers must follow normal reporting procedures.

7. Qualification/Licences:

There is no element of competition, so no special qualifications are needed. A full UK driving licence is required.

8. Insurance:

Insurance is solely the responsibility of the driver. Normally no special insurance is required for a Classic Car Tour, however you are advised to check with your Insurance provider. A minimum of Third Party Insurance for all persons who will drive participating vehicles must be applicable for the duration of the event.

9. Scrutineering:

The car must have a valid Road Fund Licence, MOT Certificate (if applicable) and Certificate of Insurance. The Driver will be required to sign a declaration confirming the car is insured and road legal. Both the Driver and Passengers will be required to sign a declaration indemnifying the Organisers from liability on the Signing on Sheet at the start of the Tour.

10. Data Protection Act:

Prospective entrants and participants are advised that information supplied on the entry form will be held on a computer and used for the administration of the event only. No information will be passed on to third parties.

11. Final Instructions:

These will be sent out after April 21st 2025 and will include a map of the Start / Finish venue and the Entry List. The Rally plates, Road Book and Map will be available at the Start which will open for registration at 9.00am.
